

2014 Claimant Calendar

INSTRUCTIONS: The Claimant Calendar is used to track the day you file your claim (Column C) and the day you get your check each week (Column D). State offices are closed on the circled holidays. Checks may be delayed during these weeks.

File your claim: Log onto www.esd.wa.gov and click on Weekly Claims. Or call 800-318-6022 (TTY 800-365-8969).

When to file: You always claim for a week after it ends. Column B shows the end date for each claim week. All weeks begin on Sunday and end at midnight on Saturday night. Sunday is the first day you can file a claim for the previous week. You can file your claim each week between Sunday and 5:00 p.m. Friday, unless it is a state holiday. Then you have until the last working day of the week. We cannot accept claims that are filed before the week is over.

Claim on time: Our Internet and telephone systems do not accept late claims. If you try to claim late, or you miss a week, you must call 800-318-6022 to restart your claim. You may be denied benefits if you do not claim on time.

Your weekly payment: Do not expect your weekly payment to arrive or post to your account the same day each week. Allow seven mail delivery days from the day you file your weekly claim.

Need a claim form: Normally, you will not need a claim form when you claim by phone or online. If you need a form, look in your Unemployment Claims Kit, contact your local WorkSource or claims center, or find them on the Internet at www.esd.wa.gov.
